**Rules:** Any boy or girl between the ages of **4 and 13** (up to 8th grade only) is eligible to participate (**two age groups will be judged: 4-7 and 8-13**); wear clothing or a "costume" that goes along with the Settlers' Days theme - costumes may be original or purchased; **winner's are required to ride on the float on Sunday** (all participants are welcome to ride on the float as well); winners will also be asked to crown next year's winners.
